

BATV Membership Form

Channel usage. "Applicant" herewith applies to Brookline Cable Community Trust Inc., known as Brookline Access Television (BATV), for use of the public access channels on the following terms and conditions:

- Applicant will not cablecast any commercial advertising intended to promote the use of goods or services, or for any information/promotion of a lottery, or for any direct solicitation of funds.
- Applicant will not cablecast any material which constitutes libel, slander, pornography, obscenity or invasion of privacy or publicity rights.
- Applicant will not cablecast any use of trademark or copyright which might violate local, state or federal law.
- Applicant agrees to make all appropriate arrangements with, and to obtain all clearances from broadcast stations, networks, sponsors, without limitation of the forgoing, any and all persons (natural and otherwise) as may be necessary to transmit its program material over the Brookline community access channels.
- In recognition of the fact that Brookline Access Television has no control over the content of the Applicant's public access cablecast, Applicant agrees to indemnify and hold BATV harmless from any and all liability or other injury (including reasonable costs of the defending claims or litigations) arising from or in connection with claims for failure to comply with any applicable laws, rules, regulations, or other requirements of local, state or federal authorities; for claims of libel, slander, invasion of privacy, or infringement of common or statutory copyright; for unauthorized use of trade-mark, trade name, or service mark; for breach of contractual or other obligations owing to third parties by company; and for any other injury or damage in law or equity which claims result from the Applicant's use of BATV.
- Applicant understands that BATV reserves the right to cancel the cablecast of any program at any time for any reason.
- Applicant states that s/he has read BATV's "Rules and Procedures" governing use of cable public access channels and agrees to abide by the terms and conditions therein.

Hardware usage. In using hardware provided by Brookline Access Television and/or Cablevision administered by Brookline Access Television for community programming by BATV, the hardware user agrees to accept the following conditions:

- Hardware must be used according to procedures described in the "Rules and Procedures Manual", copies of which are available at BATV. It is the responsibility of the user to be aware of any amendments.
- The user must not allow non-certified personnel to operate hardware. BATV will certify persons who fulfill eligibility requirements for hardware use.
- The user must take reasonable precautions to protect equipment and accessories from theft, accident, or other loss or damage.
- The user must pick up and return hardware at the prearranged time.
- The user is responsible for the proper use of hardware by others working under his/her direction.
- The user is financially responsible, up to the full deductible sum under the terms of Brookline Access Television's current insurance policy, for repair or replacement of equipment lost or damaged while in his/her care and use.

Hardware liabilities. By violating these conditions, the user might incur the following liabilities:

- Loss of hardware utilization privileges.
- Suspension or forfeiture of membership at BATV.
- Assessments for repair or replacement of hardware as a result of damage or loss due to misuse, theft, abuse, or negligence on the part of the user, up to the full deductible sum under the terms of BATV's current insurance policy. In such a case, the user is aware of BATV and Cablevision's right to place liens on the user's property or financial holdings as necessary to obtain compensation for losses.
